

Recorded Voting Trial Results – Fall 2009 Special Town Meeting

During the Fall 2009 Special Town Meeting, the Town Meeting Members Association conducted a voluntary trial of recorded voting. Over 2/3 of Town Meeting Members attending the Special Town Meeting have participated in this trial and agreed to publish their votes.

These pages are not an official government record – they contain the votes as individual Town Meeting Members themselves recorded and reported them to the TMMA. Official records, but not an individual member's voting record, are maintained by the Town Clerk.
