TMMA Annual Meeting

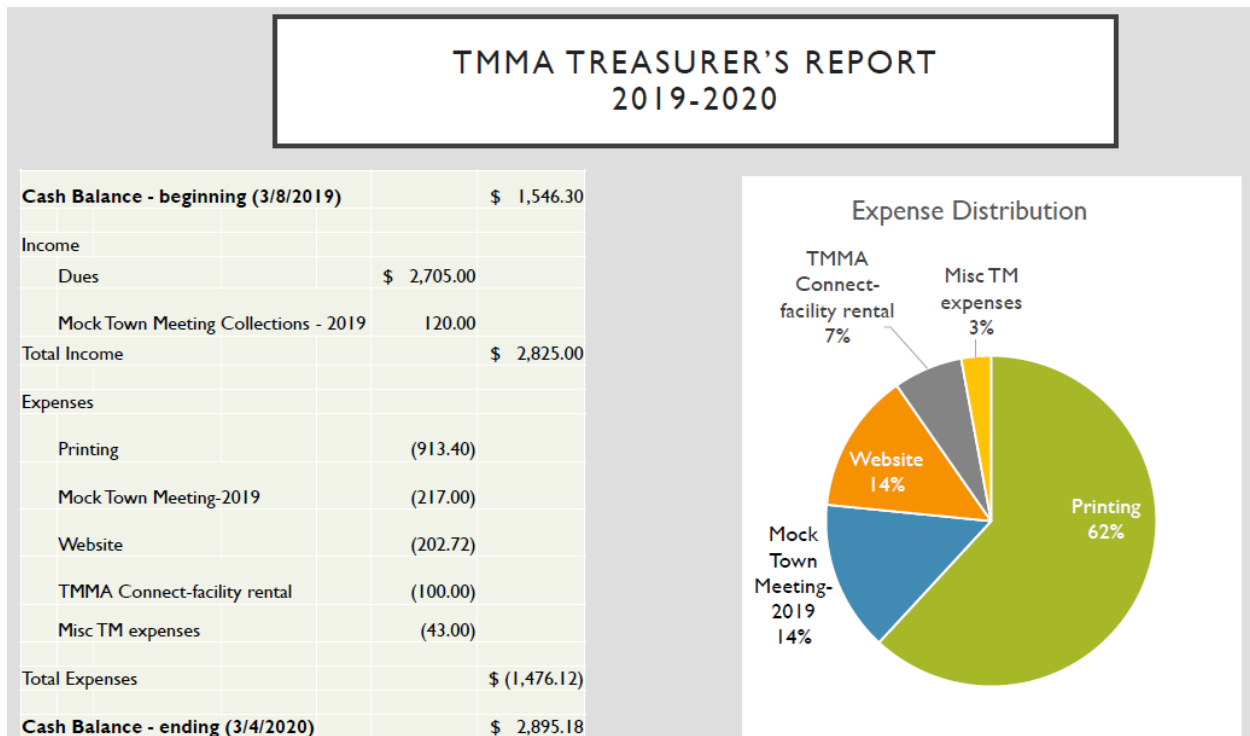
March 10, 2020

The TMMA annual meeting was held in Battin Hall in the Cary Memorial Building.

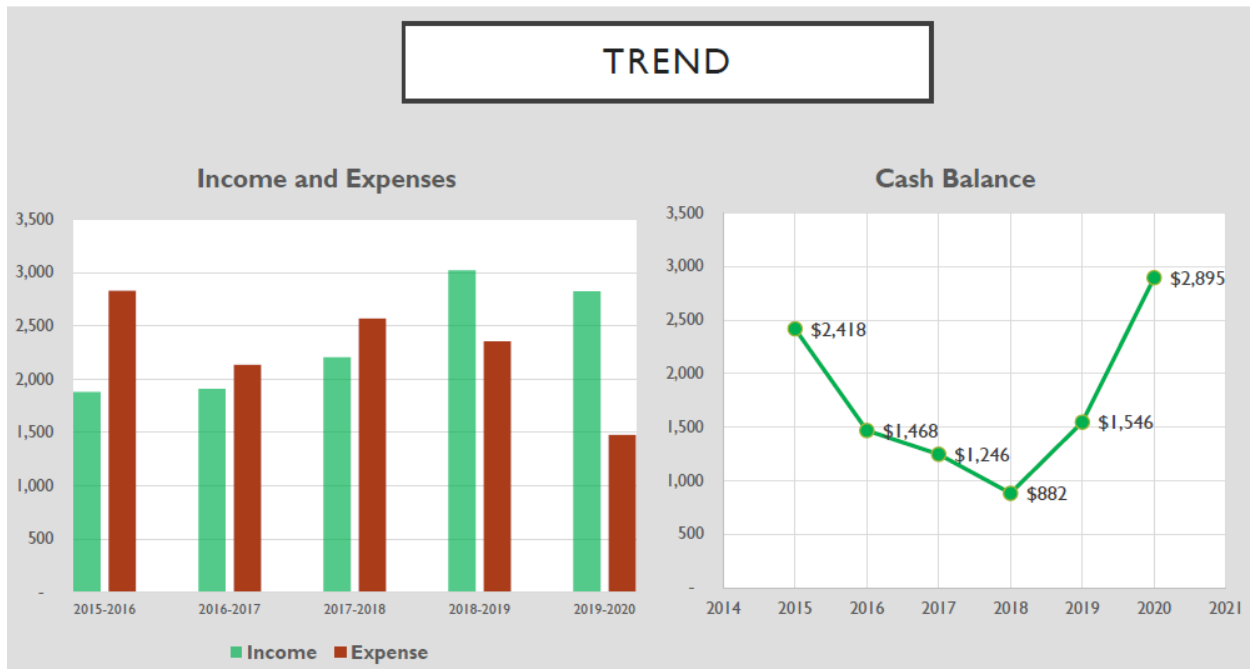
Prior to the start of the annual meeting, each of the 9 precincts meet separately to elect their three precinct officers (chair, vice-chair, and clerk) for this year.

Ben Moroze (TMMA chair) called the annual meeting to order at 7:21 PM.

- 1) Chair's Report—Ben Moroze presented the following to the TMMA membership:
 - a. Ben recognized members of the Executive Committee for organizing the first TMMA Connect! It was a successful event that TMMA hopes to continue in the future.
 - b. Due to the health of the TMMA budget, the TMMA dues will be reduced to \$10 from \$15.
