In the name of the Commonwealth of Massachusetts, you are hereby directed to notify the inhabitants of the Town of Lexington qualified to vote in elections and in Town affairs to meet at Cary Memorial Building, in said Town on Monday, November 14, 2011 at 7:30 p.m., at which time and place the following articles are to be acted upon and determined exclusively by the Town Meeting Members in accordance with Chapter 215 of the Acts of 1929, as amended, and subject to the referendum provided for by Section eight of said Chapter, as amended.

ARTICLE 1 REPORTS OF TOWN BOARDS, OFFICERS, COMMITTEES

To receive the reports of any Board or Town Officer or of any Committee of the Town.

**ARTICLE 2 APPROPRIATE FOR BRIDGE AND BOWMAN SCHOOLS
RECONSTRUCTION**

To see if the Town will vote to appropriate a sum of money to remodel, reconstruct and make extraordinary repairs to the Bridge and Bowman schools, including architectural and engineering services, original equipment and landscaping, paving and other site improvements incidental or directly related to such remodeling, reconstruction or repair; determine whether the money should be provided by the tax levy, by transfer of available funds, by borrowing, or by any combination of these methods; or act in any other manner in relation thereto.

FUNDS REQUESTED: unknown at press time

DESCRIPTION: This article requests funds for the reconstruction of the Bridge and Bowman schools to extend their useful lives. Funds for the costs of design, engineering and generation of construction documents were appropriated at the 2010 and 2011 Annual Town Meetings.

ARTICLE 3 APPROPRIATE FOR FIRE COMMUNICATION SYSTEM

To see if the Town will vote to appropriate a sum of money to upgrade the Fire Communication System; determine whether the money should be provided by the tax levy, by transfer of available funds, by borrowing, or by any combination of these methods; or act in any other manner in relation thereto.

ARTICLE 4 AMEND FY2012 OPERATING AND ENTERPRISE FUND BUDGETS

DESCRIPTION: This is an article to permit adjustments to current fiscal year (FY2012) appropriations of the general fund and enterprise fund budgets.

DESCRIPTION: This article proposes to establish and/or fund Stabilization Funds for specific purposes. Money in those funds may be invested and the interest may then become a part of the particular fund. The use of these funds may be appropriated for the specific designated purpose by a two-thirds vote of Town Meeting.

ARTICLE 6

APPROPRIATE TO STABILIZATION FUND

To see if the Town will vote to appropriate a sum of money to the previously created Stabilization Fund in accordance with Section 5B of Chapter 40 of the Massachusetts General Laws; determine whether the money shall be provided by the tax levy, by transfer from available funds, or by any combination of these methods; or act in any other manner in relation thereto.

FUNDS REQUESTED: unknown at press time

DESCRIPTION: Money may be appropriated into the existing Stabilization Fund. The balance of the Fund may be invested and the investment income will become part of the fund. These funds may later be appropriated, by a two-thirds vote of an Annual or Special Town Meeting, for any lawful purpose.

ARTICLE 7

APPROPRIATE FOR AUTHORIZED CAPITAL IMPROVEMENTS

To see if the Town will vote to make supplementary appropriations to be used in conjunction with money appropriated in prior years for the installation or construction of water mains, sewers and sewerage systems, drains, streets, buildings, recreational facilities or other capital improvements and equipment that have heretofore been authorized; determine whether the money shall be provided by the tax levy, by transfer from the balances in other articles, by transfer from available funds, including enterprise and community preservation funds, by borrowing, or by any combination of these methods; or act in any other manner in relation thereto.

FUNDS REQUESTED: unknown at press time

DESCRIPTION: This is an article to request funds for capital improvement project expenditures that exceed the level of appropriation.
